# Terms and conditions for supply of Equipments as per enclosed list for B.R.P. Govt. Polytechnic, DHAMTARI

The tender is liable to be rejected if not submitted as per the prescribed conditions and in the prescribed format without asking any further clarification.

- 1. The bidder should quote their offer / rate in clear terms without any ambiguity.
- 2. The tender will be opened as per the date and time given above in the presence of such tenderer (s) or their representatives who are desirous to be present.
- 3. Tender received after due date and time will not be entertained.
- 4. The tender form is non transferable.
- 5. Tender should be submitted in Duplicate. They should be tagged separately and marked as original and duplicate.
- 6. Item no. and page no. of the tender form should be strictly in chronological order. Make, name of the manufacturer with complete address should be mentioned against each item and equipment.
- 7. Printed condition on the back of the tender will not be binding unless separately mentioned. Copies of the terms and condition should be furnished in duplicate.
- 8. The tenderer must furnish complete and detailed specification supported by printed literature of the equipment offered.
- 9. All the Envelopes should be signed & sealed tape on all joints.
- 10. The rate should be FOR destination including Excise and PFFI. Nothing extra will be paid in such case except the VAT/CST on the cost of the equipment.
- 11. If rates are quoted ex-godown/ex-factory then Excise duty, and PFFI charge should be clearly indicated for proper rate compatibility/ comparability.
- 12. Taxes, if livable extra, should be clearly indicated failing which the rate quoted in the tender will be considered as inclusive of all taxes.

- 16. In case of non-acceptance of the tender, the EMD will be refunded without interest to the renderer in due course of time. The EMD will be treated as security deposit in case of selected tenders. EMD /Security deposit will be forfeited in case of breech of agreement of supply by the tenderer (supplier). The order shall stand cancelled and security deposit forfeited.
  - i. If supplier expresses his inability to execute the order for the quoted items within validity period of the tender at the rate quoted in the tender and for makes / brand quoted in the tender.
  - ii. If the complete equipment is not supplied within the delivery period mentioned in the order or within the extended period permitted.
  - iii. If the supplier executes only part of the order.
  - 16. Any Equipment / Trainers, Hardware or software breakdown must be attended within 7 days during the valid warranty period of the equipment/software free of cost.
  - 17. Payments shall be released after the successful installation and demonstration of the machine / equipment at the respective institution.
  - 18. The training for at least two persons for handling the machine / equipment shall be provided by the supplier at his own cost.
  - 19. The renderer may be asked to give demonstration of the equipments /software preferably at Dhamtari.
  - 20. The supplier will have to get the equipment delivered, installed and commissioned successfully as per specification in the designated institution and then only the payment will be made in rupees.
  - 21. The one time extension in the delivery period may be granted at the discretion of the undersigned. The penalty at a rate of 2% per month of the full cost of the equipment is liable to be charged for the extension of the delivery period.
- 22. Equipment received after the delivery period or dispatched after the delivery period mentioned in the order will also be subjected to this penalty.
- 23. In case of any default in execution of the order, the undersigned reserves the right to forfeit the EMD/Security deposit. The undersigned also reserves the right to cancel the order and forfeit the EMD/Security deposit in case the renderer fails to adhere strictly to all terms and condition of the order/tender.
- 24. If defects of any kind or deviations from the specification are detected and reported to the supplier, the supplier should make replacement or rectify the defects free of cost within 30 days from the date of report, failing which the equipment will not be accepted and will be returned to the

supplier at his own cost and risk, and the EMD will be forfeited. In case the equipment is sent for repairs to the firm, it should be repaired within 30 days, from the date of receipt of equipment failing which the same will not be accepted and EMD will be forfeited. However the undersigned may condone the delay in deserving cases at his discretion.

- 25. The undersigned reserves the right to increase/decrease the quantity of the equipment to be supplied.

- 32. All items quoted must conform to the BIS/ISO Certificate as far as possible.
- 33. No advance payment will be made.
- 34. The tenderer/bidders shall provide **TIN No. Certificate** having mentioned tendered item. Sales Tax Clearance certificate from the concerned authority and should be attached with the tender. In case of imported Machinery bill of clearance is required Tender received without these certificates shall be rejected.
- 35. The minimum warrantee period for the equipment supplied by the supplier will have to be mentioned clearly which should not be less than one year from the date of installation. The tenderer will be required to undertake repair / replacement of defective parts free of cost at the institution during the guarantee period.
- 36. All the disputes with regard to the contract of purchase of equipment etc. is subjected to Dhamtari, Chhattisgarh Jurisdiction only.
- 37. In the event of the order, supplier who are the manufacturer of the equipment will be required to furnish a certificate to the effect that they are manufacturers of such and such make

- 38. The equipment /machinery calibrated in metric/SI system need be quoted.
- 39. The renderer shall guarantee that after sales service shall be provided as and when required.
- 40. The supplier will render necessary assistance, if required, in the installation of the equipment /machinery in the designated institute (s)/site free of charge.
- 41. No offer should be made for imported item for which import license has to be arranged by the undersigned. The entire imported item will have to be delivered in the designated institute (s) and payment will be made in Rupees.
- 42. The payments shall be released only after satisfactory and successful commissioning and installation of the equipment /machinery at the designated site / institute (s).
- 43. The rate quoted as per given format in Annexure II. Packing, forwarding, freight, insurance and other incidental charges should be included in that.
